


CIO-SP4 Proposal Submission Guide via the Secure Email and File Transfer Service (SEFT) To initiate the proposal submission process through SEFT, you must first register at https://nih.force.com/CIOSP4/s/. Registration must occur 24 hours before the due date of proposals. Fill out the required fields and then click Next.



You'll see the following message confirming receipt of your information.

Thank you for submitting your registration data for the CIO-SP4 proposal submission. Your information was successfully received and you will receive an email on Wednesday, July 28, 2021 that will contain instructions on how to submit your proposal. If you registered after July 28th, a daily email will be sent out to ensure you receive those instructions. The source for all information pertaining to CIO-SP4 is www.sam.gov, therefore please be sure to monitor that site for any guidance and updates. You may close this browser tab anytime.

Not immediately but soon after, you'll receive a notification message via SEFT. Be sure to check your junk/spam folder.





Click Register once all the required fields are filled out. Then you'll see the following message.

After registering, you'll receive an email with the subject line "Secure File Transfer account activation link" notifying you that you have registered for an account. Click on the activation link provided in the email. You'll the receive an email with the subject line "Welcome to Secure File Transfer" notifying you that your account has been activated.



From your Inbox, open the email with the Subject line "CIO-SP4 Proposal Submission Instructions".




Below is an example of the message.

To respond to the email, scroll down to the Reply section, attach your proposal package as a zip file by clicking Attach files , include a message in the body of the text, and then click Send reply . Below is an example.



NOTE: SEFT does not provide read receipts nor will the Government reply confirming receipt of your proposal.

For a record of your submission, click on and then and then brint and/or save the document as a PDF. Below is an example of the record which displays the date and time of the submission.

Also, the SEFT Service does not provide read receipts. Therefore, for a record of your submission, please click on the "Action" dropdown from within your sent message and then select "Print".
